Telephone, email and unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Make all checks and money orders payable to Upper Iowa Training Club. Payment must accompany entries.

Mail all entries to Abby Flak, 3706 Co Rd W40, Decorah, IA 52101. Entries received without fees will not be accepted. Acknowledgment of entries will be made as soon as practical. Unless an exhibitor specifically requests postal communication, submission of an email address on the entry form will serve as authorization to send communication, including entry confirmation via email. It is the exhibitor's responsibility to ensure that their email software will accept messages from abbyflak@gmail.com

Entry fees shall not be refunded if a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of Show Committee or AKC. The well-being of dogs, exhibitors and spectators is of paramount importance, and in the event, it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.

UITC does not agree to arbitrate claims as set forth on the Official AKC Entry Form for the events.

Owners are responsible for errors in completed entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date. Changes, additions or corrections to entry forms must be received prior to the closing of entries.

Post-dated and returned checks do not constitute a valid entry. A collection fee will be added to the amount of each returned check.

No refund for duplicate entries. Care will be taken to find duplicates, however, if an entry has been processed, no refund will be made. No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. There will be no refunds of entry fees if a person is asked to leave the trial site.

Dogs may arrive at any time prior to their scheduled judging. Dogs not required for further judging may be excused. Owners or agents are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

UITC, the show secretary, members of the show committee, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, their employees or children, etc. or to any of their dogs or property. Entrants and spectators at this show do so entirely at their own risk.

Rally Regulations: ALL DOGS MUST be on leash or kenneled unless they are shown in the ring.

Upper Iowa Training Club (UITC) may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against UITC or any official thereof. No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. UITC reserves the right to cancel these trials in the event of extreme weather conditions and no entry fee refunds will be made in such a case. Bitches in season are not permitted in the Trial. Exhibitors may request a refund of entries, minus a \$10 per entry processing fee, for bitches that come into season after the closing date, as long as the trial secretary is provided documentation from a veterinarian at least 30 minutes prior to the beginning of the day's judging. Upper Iowa Training Club policy allows the Obedience/Rally trial secretary to enter these events. Refunds will not be given for over payments of \$10 or le

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
